It is proposed to fill up 01 vacancy (DENTAL SURGEON) of Medical Officer by engaging full time Dental Surgeon purely on contract basis for a period of one year, to serve in Central Hospital of South East Central Railway as per the details given below: -

**2. Eligibility Conditions/Qualifications:-**

<b>A)CMP/GDMO (Dental Surgeon)</b>	Bachelors in Dental Surgery with three years of minimum working experience or Post Graduate degree in Dental Surgery from any recognized medical college/university with valid registration with Indian Dental Council. In addition, retired Railway Doctors/retired Government Doctor of State/Central Govt. up to the age of 67 years is also eligible with same qualification.

**3. Reservation:** For EWS (Economically weaker sections) category Candidate.

**4. Other details are as follows:-**

Monthly Honorarium	Monthly honorarium will be payable in terms of Railway Board's guideline as specified from time to time. Presently, monthly honorarium payable is as under:
Dental Surgeon (full time)	<b>Rs75,000/-</b> (Rupees Seventy five thousand only) per month.
Retired Doctors	<b>Rs75,000/-</b> (Rupees Seventy five thousand only) per month (Subject to the condition that remuneration + pension drawn by retired doctor should not exceed the last pay drawn)

**5. Age :-**

1. Entry level age limit of candidates for appointment as Contract Medical Practitioners (CMPs) is 53 years.
2. The maximum age limit is 65 years or 12 terms whichever is earlier, and each terms of engagement shall not exceed more than one year.
3. For Retired/Government doctor: -  
The number of annual terms of engagement of Retired/Government doctor engaged as CMPs, is revised from the existing FIVE to SEVEN subject to attaining the age limit of 67 years, whichever is earlier and each term of engagement shall not exceed more than one year.


<b>6. Mode of engagement and venue :-</b>	Selection through "Walk in interview"/ Interview through online Platform. <b>7. Period of contract:-</b>	Contract period is normally for one year. Extensions of contract can be considered for further periods as per extant rules. Contract can be terminated by either side at any time by giving 15 days' notice. The contract can also be terminated by the Railway administration at any time during the contractual period by giving 15 days notice without assigning any reasons whatsoever.

Candidates are requested to give their correct phone number. Short listed candidates should make all arrangements for appearing for screening immediately after the date of closing of the notification.
- Candidates may apply in the prescribed format and send along with document required on or before for Dental Surgeon 30.04.2022 to above mention address.
- The interview may be extended to more than one day depending on number of applicants. No TA/DA/Accommodation will be provided to the candidates attending the interview.
